AUTHORIZATION TO CONDUCT A CREDIT INVESTIGATION

If applying for credit, please sign this authorization ("Authorization"). By signing this Authorization:

1. I authorize Dealer, Istate Truck Center, and any other finance company, bank, or other financial institution to which the Dealer and/or other financial institutions submit my application ("you" or "Your") to investigate my credit and employment history (if an individual), obtain credit reports, contact, any of my current or former creditors to verify any information contained herein or received in connection with this Authorization or the accompanying credit application which You deem relevant to the possible extension of credit to me ("Information"), and release information about Your credit experience with me as the law permits. I authorize Istate Truck Center and any financial institutions to disclose Information to any affiliate, assigns or agent.
2. If required by the transaction, I authorize Istate Truck Center and any other financial institution to file a UCC Financing Statement.
3. I intend to use the purchased or leased Equipment primarily for business or commercial purposes, and not for personal, family, household or agricultural purposes. Generally speaking, the term agricultural purposes does not mean over the road transportation or hauling of goods.
