1. I authorize Dealer, Istate Truck Center, and any other finance company, bank, or other financial institution to which the Dealer and/or other financial institutions submit my application ("you" or "Your") to investigate my credit and employment history (if an individual), obtain credit reports, contact, any of my current or former creditors to verify any information contained herein or received in connection with this Authorization or the accompanying credit application which You deem relevant to the possible extension of credit to me ("Information"), and release information about Your credit experience with me as the law permits.
